Explanation of Responses:

- These restricted stock units, which convert into common stock on a one-for-one basis, vest one-third on each of the first three anniversaries of the 9/3/2015 grant date.
- These restricted stock units, which convert into common stock on a one-for-one basis, vest one-third on each of the first three anniversaries of the 9/3/2016 grant date.
- These restricted stock units, which convert into common stock on a one-for-one basis, vest one-third on each of the first three anniversaries of the 3/21/2017 grant date.
- This option vests one-third on each of the first three anniversaries of the 9/3/2014 grant date.
- This option vests one-third on each of the first three anniversaries of the 9/3/2015 grant date.
- This option vests one-third on each of the first three anniversaries of the 9/3/2016 grant date.
- This option vests one-third on each of the first three anniversaries of the 3/21/2017 grant date.
- This option vests one-third on each of the first three anniversaries of the 9/14/2017 grant date.
- Each of these Warrants entitles the holder to purchase one share of common stock; however, for each Warrant exercised, the holder will receive a net share amount equal to the number of shares issuable upon the exercise multiplied by the closing sale price of the common stock on the exercise date minus the exercise price, divided by the closing sale price, together with cash for any fractional shares.
